Tactical decisions

Market reactions are often irrational, which creates disruptions that may change the current risk/reward profile of certain asset classes from longer-term expectations. When market conditions present such opportunities, the MAS Team can, in most of the portfolios they manage, temporarily deviate from the strategic allocation to reduce risk or take advantage of opportunities. And it is not a binary decision. Over 30 independent decision points (across three levers: asset mix, asset style and asset class) factor into the top-down tactical view.

Integration of ESG within Granite Portfolios

Sun Life Global Investments considers environmental, social and governance (ESG) factors to be an increasingly important component of the investment manager selection and oversight process. We believe that ESG factors may materially affect the financial performance of individual securities.
